**Participation of UNSU staff representatives in CCISUA General Assembly
Valencia, Spain, 29 April-3 May 2013**

The Staff Council,

Noting that the United Nations Staff Union is affiliated to CCISUA at the Federation level;

Further noting that the CCISUA General Assembly will take place in Valencia, Spain, from 29 April to 3 May 2013;

Taking into account that the costs of the participation of the President of the Union at the CCISUA GA will be limited to DSA in Valencia, terminal indemnities as they relate to Valencia and a portion of the air ticket expenses (since the President will attend other meetings in Europe around the same period in her capacity as Vice-President of CCISUA);

The Staff Council,

Decides to nominate Meriam Gueziel, Egor Ovcharenko, and Guy Candusso to attend the CCISUA GA in addition to the President;

Further decides to authorize, upon presentation of proper documentation, and based on the enclosed estimated budget, a total amount of \$ 20,000 for the payment of travel and other related costs for the representatives of the Union, who will report in writing to the Council upon their return.
