UNSU delegation to the 62nd Pension Board meeting
Geneva, Switzerland, 20-24 July 2015

The Staff Council,

Considering the current situation at the Pension Fund and on-going negotiations to implement a new Memorandum of Understanding (MoU) and how this would impact the Fund, its staff and the overall administration of the Pension Fund;

Noting that the current OIOS investigation into allegations of wrong-doing at the Pension Fund, including elements of the draft MoU, may have been concluded;

Further noting that there has been a decision by the Administration to release information of the report only after the Pension Board meeting ends;

Recognizing the need to keep staff informed and to fight the implementation of the MoU if it is to the detriment of participating members and beneficiaries of the Pension Fund alike;

Decides to send up to two Pension Fund staff representatives to attend the 62nd meeting of the Pension Board to take place in Geneva from 20 to 24 July 2015 as part of CCISUA's delegation to serve as advisors;

Further decides to authorize, upon presentation of proper documentation, and based on the enclosed estimated budget, a total amount of \$15,000 from the Staff Union Reserves Fund, for the payment of travel and other related costs for the participants.

Requests the President of Staff Union to request the release of the selected Staff Representatives for official travel from their respective department(s);
