**New York Local Salary Survey –  
Announcement of result and related discussions**

*The Staff Council,*

*Considering* the importance for staff members of the result of the New York local salary survey, which will be made public and discussed during the next session of the International Civil Service Commission – ICSC (Vienna, 27 July to 7 August 2015);

*The Staff Council,*

*Decides* to fully fund the travel expenses to Vienna of Meriam Gueziel and Katy Joseph-Solozano, both staff nominated members of the Local Salary Survey Committee, so to enable their participation in a technical meeting to take place on Saturday 1 August and in discussions related to the survey during the ICSC session after that;

*Further decides* to send up to four additional participants who are members of the Staff Council and the Executive Board so that they engage with the ICSC Secretariat and Commissioners, as well as with the Administration, on the result of the salary survey;

*Authorizes* the expense up to USD \$67000 from the United Nations Staff Union Reserves to cover the costs associated with the travel of all participants for the purpose at hand;

*Requests* the President of the United Nations Staff Union to inform the pertinent supervisors that the attendance records of UNSU representatives while in Vienna are to reflect the official character of the mission.
