**Resolution on the participation of UNSU in the CCISUA 31st General Assembly
 Santiago, Chile, 13-17 June 2016, and
 UNSU's 2016/17 financial contribution to CCISUA**

The Staff Council,

Noting that the United Nations Staff Union is affiliated to CCISUA at the Federation level and that the next CCISUA General Assembly will take place in Santiago, Chile, from 13 to 17 June 2016;

Also noting that Mr. Egor Ovcharenko (Rapporteur) is a member of the current CCISUA Bureau and Ms. Meriam Gueziel (Treasurer) was CCISUA's Treasurer until recently;

Noting further that, in order for CCISUA to continue to fight the challenges faced by UNSU and its members at the UN Secretariat and Common System levels, additional financial support is needed;

The Staff Council,

Decides to send, in addition to the United Nations Staff Union's President, Rapporteur (currently CCISUA's Vice-President for Conditions of Service) and Treasurer, three Staff Representatives to attend the CCISUA GA;

Further decides to authorize, with funds from the from the UN Staff Union Reserves, upon presentation of proper documentation, and based on the enclosed estimated budget, up to a total amount of \$ 51,000 related to the travel of the Union representatives to attend the GA;

Finally decides that UNSU's annual financial contribution to CCISUA for 2016/17 will be in the amount of \$ 36,000.
