**Resolution on the participation of UNSU staff representatives at
83rd session of the International Civil Service Commission, 25 July to 5 August 2016
Geneva, Switzerland**

The Staff Council,

Noting that the International Civil Service Commission has started its review of the conditions of service of staff in general service and related categories;

Also noting that issues related to the “S” category are on the agenda of the 83rd session of the International Civil Service Commission, to be held from 25 July to 5 August 2016 in Geneva, Switzerland;

Noting further that CCISUA, the federation of which United Nations Staff Union is a member, is an observer to the International Civil Service Commission and in its observer capacity can benefit from the advice of experts;

Decides to nominate two Staff Representatives of the “S” category to attend the 83rd session of the International Civil Service Commission, namely Katy Joseph-Solozano and Valentin Stancu, so to observe the pertinent discussions and advise the CCISUA representatives on the specific “S” category matters, as well as to advocate for better recognition and conditions of service for the “S” category staff;

Further decides to authorize, with funds from the from the UN Staff Union Reserves, upon presentation of proper documentation, and based on the enclosed estimated budget, up to a total amount of \$ 16,000.00 related to the travel of the Union representative to attend the ICSC session.
