**Resolution on the participation of the United Nations Staff Union 1st Vice President on the ICSC
85th Session in Vienna, Austria**

15 July - 22 July 2017

The Staff Council,

Noting that the issues related to the “S” category are on the agenda of the 85th Session of the International Civil Service Commission under “Any other business” to be held from 10 July to 21 July in Vienna, Austria.

Noting further that CCISUA, the federation of which United Nations Staff Union is a member, is an observer to the International Civil Service Commission and in its observer capacity can benefit from the advice of experts;

Decides to nominate the United Nations Staff Union 1st Vice President of the “S” category to attend the 85th Session of the International Civil Service Commission in Vienna from 15 July to 22 July 2017 and to observe the pertinent discussions, advise the CCISUA representatives on the specific “S” category matters, as well as to advocate for better recognition and conditions of service for the “S” category staff;

Further decides to authorize, with funds from the UN Staff Union Reserves, upon presentation of proper documentation, and based on the enclosed estimated budget, up to a total amount of US \$ 4,000 related to the travel of the UN Staff Union delegation of 1 Representative to attend the ICSC 85th Session.
