Resolution on the participation of the UNSU representatives at the IX session of the Staff Management Committee Addis Ababa, Ethiopia, 20 – 27 April, 2020

The Staff Council,

Noting that the United Nations Staff Union – New York is a member of the Staff-Management Committee (SMC) and that SMC IX will take place in Addis Ababa, Ethiopia, from 20 to 27 April 2020;

Noting that prominent items on the agenda shall include, *inter alia*, Downsizing, Delegation of Authority, Mobility and Staff Selection;

Noting also that travel expenses for the two senior ranking members of each delegation shall be covered by the administration, under the terms of ST/Al/2014/3;

The Staff Council,

Decides that the UNSU delegation to SMC IX shall be composed of the President, First Vice-President, Second Vice-President, Staff Council Secretary and the staff representative for Unit 14;

Further decides to authorize, with funds from the UN Staff Union Reserves, upon presentation of proper documentation and based on the enclosed estimated budget, up to a total amount of USD 23,000 related to the travel of three members of the UN Staff Union delegation to attend SMC IX;

Instructs the Leadership to request the release of the selected Staff Representatives for official travel from their respective department(s) and to inform the SMC President of the terms of the present Resolution.
